The following are examples of the types of behavior that conflict with the community standards that <u>UH</u> values and expects of students. Engaging in, or attempting to engage in any of these behaviors subjects a student to the disciplinary process and sanctions on each campus.

- 1. Acts of dishonest , including but not limited to the following:
 - a. Cheating, plagiarism, or other forms of academic dishonesty. Cheating is an act of academic dishonesty and includes, but is not limited to: (1) use of any unauthorized assistance in taking quizzes, tests, or examinations; (2) use of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; (3) the acquisition, without permission, of tests or other academic material belonging to a member of the <u>UH</u> faculty, sta or student body; and (4) engaging in any behavior specifically prohibited by a faculty member in the course syllabus or class discussion.

Plagiarism is also an act of academic dishonesty and includes, but is not limited to, the use, by paraphrase or direct quotation, of the published or unpublished work of another person without full and clear acknowledgement. It also includes the unacknowledged use of materials prepared by another person or agency engaged in the selling of term papers or other academic materials.

- b. Furnishing false information to any <u>UH</u> o cial, faculty member, or o ce.
- c. Forgery, alteration, or misuse of any <u>UH</u> document, record, or form of identification.
- 2. Disruption or obstruction of teaching, research, administration, disciplinar proceedings, other <u>UH</u> activities, including its public service functions on or o campus, or of other authorized non-<u>UH</u> activities when the conduct occurs on <u>UH</u> premises. This includes creating noise or other disturbances on campus or in student life areas su cient to disrupt the normal functioning of campus activities including classroom instruction.
- 3. An conduct that threatens or endangers the health or safet of an person including but not limited to, physical abuse, verbal abuse, threats, intimidation, harassment, bullying, coercion, stalking as defined below. (For any conduct that is sexual or romantic in nature and committed by a current or former partner of an intimate, romantic, or sexual relationship, or is related to an individual's actual or perceived sex or gender, sexual orientation, gender identity or gender expression, refer to <u>ER</u> 1.204 for detailed information.)
 - a. Threat is written or verbal conduct that causes a reasonable expectation of injury to the h

intimidate or intentionally harm or control another person physically or emotionally, and are not protected by freedom of expression.

- d. Stalking is two or more acts of unwanted and harassing behavior, directed at a specific **petropetration** petropetric **petropetration**, or psychological fear or to create a hostile, intimidating or abusive environment.

- 10. Failure to compl 'ith an directions of <u>UH</u> o cials or la ' enforcement o cers acting in performance of their duties and /or failure to provide identification to these persons when requested to do so.
- 11. **Unauthori ed possession, duplication, or use of ke s/ke cards/securit mechanisms** to any <u>UH</u> premises or unauthorized entry to or use of <u>UH</u> premises, including trespassing, propping or unauthorized use of doors for entry into or exit from a <u>UH</u> building.
- 12. **Violation of an <u>UH</u> polic , rule, regulation, contract, or agreement** published in hard copy or available electronically on any <u>UH</u> website.
- 13. Violation of an federal, state, or local la **1**.
- 14. Use, possession, manufacturing, or distribution, or other unauthori ed use of controlled substances or paraphernalia except as expressly permitted by law. Controlled substances include but are not limited to marijuana, methamphetamine, narcotics, and opioids.
