IIA. Transylvania University has multiple policies that violate the fundamental speech rights of students, violating not only their own stated values, but also the spirit of education and SACSCOCÕs veRyhilosophy of Accreditation. By restricting speech to a heavily obstructed quarantine zone and requiring a heavily bureaucratic permit process (Supporting Document 2a), Transylvania University has fostered a climate that is hostile to open expressiexchaege of ideas, and dissenting beliefs. TransylvaniaÕs ÒFree Speech, Protests and Demonstration PolicyÓ directly goes against the values of SACSCOC and devalues the liberal arts education Transylvania University promises. Given that this university deserved this policy to target student

IIB. Statement of Facts can be viewed in Supporting Document 2a. On May 0990 2 TransylvaniaOs Young Democratic Socialists of America (YDSA) tabled outside the speech guarantine zone without interference. The next day, however, the Young Americans for Freedom (YAF) chapter tabled at the same time, place, and manner as the protocol organization. The difference, however, is that the administration shut down the YAF chapter two minutes after they set up. In this blatant act of viewpoint discrimination, Transylvania showed the dangerous nature of their scalled OFree Speed Protests and Demonstration Policy. O During this incident, Dean of Students Michael Covert threatened the students with even more restrictive policies. While the university has claimed to the media that they will be reviewing their policies over the summer(Supporting Document 4f), we have been informed by an unnamed respondent to Will CreeleyÖs letter to Transylvania University (Supporting Document 2) that they are committed to enforcing these antree speech policies that go against SACSCOCOs philoscopy izing the Oright of students to access opportunities for learning and for the open expression and exchange of ideas. O The policies that Transylvania University has implemented violates the Philosophy of Accreditation, and the very nature of educatteelf. By requiring permission slips to talk to other students (Supporting Document 1a, 1c), Transylvania University explicitly violates SACSCOCOs accreditation standards, their promise of free speech (Supporting Document 1b, 2bi, 3a, 3c), and the reasonal expectations of students. The initial act of institutional censorship occurred on May 2nd, 2019. I and my fellow students have explored our options since that incident.

IIC. I am currently receiving help from the Foundation for Individual Rights in Etiton (FIRE)

led to no resolution. With this in mind, Will Creeley, an **attey** with FIRE, sent a letter to the University explaining why they have failed to meet their contractual obligations to respect the free speech rights of students (Supporting Document 2). The University sent an abysmally insufficient response to our legationcerns in which they pledged to continue these policies that not only violate their contract with the student body, but also violates their contract with SACSCOC (Supporting Document 6), and has not responded since. Aside from this Accreditation Complatit, we have exhausted all other options outside of the legal realm. At the moment, I am not considering legal action against the university.
